

SMS MESSAGING TERMS AND CONDITIONS

Action Accounting, LLC, "we", or "us") operates a SMS messaging program (the "<u>Program</u>") subject to these SMS Messaging Terms and Conditions (these "SMS <u>Messaging Terms</u>"). The Program and our collection and use of your personal information is also subject to our Privacy Policy. Visit our Website to see Privacy Policy. By enrolling, signing up, or otherwise agreeing to participate in the Program, you accept and agree to these SMS Messaging Terms and our Privacy Policy.

- 1. Program Description: We may send promotional and transactional SMS messages in various formats through the Program. Promotional messages advertise and promote our products and services and may include notifications, updates, promotions, specials, other marketing offers, and customer support. Transactional messages relate to an existing or ongoing transaction and may include order notifications and updates, appointment reminders, and other transaction-related information. SMS messages may be sent using an automated technology, including an autodialer, automated system, or automatic telephone dialing system. Message frequency will vary. You agree that we, our affiliates, and any third-party service providers may send you messages regarding the foregoing topics or any topic and that such messages and/or calls may be made or placed using different telephone numbers. We do not charge for SMS messages sent through the Program but you are responsible for any message and data rates imposed by your mobile provider, as standard data and message rates may apply for short message service and multimedia message alerts.
- 2. User Opt-In: By providing your mobile phone number to us, you are voluntarily opting into the Program and you agree to receive recurring SMS messages from us at the mobile phone number associated with your opt-in, even if such number is registered on any state or federal "Do Not Call" list. You agree that any mobile phone number you provide to us is a valid mobile phone number of which you are the owner or authorized user. If you change your mobile phone number or are no longer the owner or authorized user of the mobile phone number, you agree to promptly notify us at Support@ActionAccountingusa.com. Your participation in the Program does not require that you make any purchase from us and your participation in the Program is completely voluntary.
- 3. User Opt-Out and Support: You may opt-out of the Program at any time. Our SMS messaging platform may not recognize requests that modify the foregoing commands, and you agree that we and our service providers will not be liable for failing to honor requests that do not comply with the requirements in these SMS Messaging Terms. We may also change the telephone number or short code we use to operate the Program



and we will notify you of any such change. You acknowledge that any requests sent to a telephone number or short code that has been changed may not be received by us and we will not be responsible for failing to honor a request sent to a telephone number or short code that has been changed.

- 4. **Disclaimer of Warranty and Liability:** The Program is offered on an "as-is" basis and may not be available in all areas, at all times, or on all mobile providers. You agree that neither we nor our service providers will be liable for any failed, delayed, or misdirected delivery of any SMS message or information sent through the Program.
- 5. Modifications: We may modify or cancel the Program or any of its features at any time, with or without notice. To the extent permitted by applicable law, we may also modify these SMS Messaging Terms at any time. Any such modification will take effect when it is posted to our website. You agree to review these SMS Messaging Terms periodically to ensure that you are aware of any modifications. Your continued participation in the Program will constitute your acceptance of those modifications.
